

## How do we process your data?

Due to the entry into force of Regulation (EU) 2016/679 of the European Parliament and of the Council (May 25, 2018), ERES-Partner sp.z o. O. Sp.k. adjusted the processing of personal data to the new rules.

## Who is the Administrator of your personal data?

The administrator of your personal data, i.e. the entity that will decide on the method of their use, is: ERES-Partner sp. Z o. O. Sp. K. With its registered office in Krakow, Os. Mozarta 7/11, NIP: 9442266886.

## What is the purpose and legal basis for the processing of your personal data?

The basis for the processing of your personal data is a cooperation agreement with a Partner for services provided by Uber, Bolt or FreeNow in Poland. ERES-Partner Sp. z o.o. Sp.k. processes your personal data for the following purposes:

1. concluding and performing the contract that connects us (Article 6 (1b) of the GDPR - performance of the contract);
2. contact regarding the contract that binds us (Article 6 (1b) of the GDPR - performance of the contract);
3. handling your inquiries and complaints, including solving technical problems (Article 6 (1c) of the GDPR - performance of our legal obligations);
4. making settlements (Article 6 (1c) of the GDPR - performance of legal obligations incumbent on us);
5. conducting court and administrative proceedings (art.6 par.1 f, GDPR - our legitimate interest);
6. for marketing purposes (Article 6 (1) and the GDPR - consent);
7. Possible other circumstances resulting from the cooperation process and necessary for its legally correct implementation

## What personal data do we process?

- Name and surname,
- PESEL number,
- Document numbers / series (ID cards, passports, driving licenses, residence cards, etc.),
- Information on no criminal record,
- information on possible other sources of income,
- e-mail addresses,
- telephone numbers

- documents related to claims (eg letters from bailiffs, courts, police),
- documents with vehicles of cooperating persons,
- bank account numbers,
- information about owned cars.

## **Do you need to name your personal details?**

Providing personal data is a guarantee that it is necessary to provide services ensuring the performance of the cooperation agreement with ERES-Partner sp. Z oo o. Sp.z o.o. k. If the data is present when provided, the contract will not be possible. Thus, you will not be able to execute any orders for Uber, Bolt or FreeNow.

## **Personal data is processed:**

- in compliance with the provisions on the protection of personal data,
- to the extent and for the purpose necessary to fulfill legitimate interests (legitimate purposes), and the processing does not violate the rights and freedoms of the data subject, information,
- in considering and solving legal or technical problems (related to, for example, services provided by companies cooperating in the field of car rental),
- in the scope of obligations arising from legal provisions, including tax and accounting regulations, the basis for processing will be Art. 6 sec. 1 lit. c) GDPR. You have the right to access your personal data and correct them, request the cessation of their processing and object to their processing in the cases referred to in art. 32 sec. 1 points 7 and 8 of the Personal Data Protection Act.

## **How long will personal data be stored?**

For the period of cooperation with ERES-Partner sp. Z o. O. Sp. K., As well as for the time necessary to pursue possible claims or for the period required by tax law, but not longer than 5 years from the end of the contract.
